# 6 Days August 17, 2014

#### Day 1: Arrive Calgary - Banff

Welcome to Calgary, Alberta's cosmopolitan city. Meet your Tour Director and depart for Banff National Park and the charming town of Banff for a 5-night stay at one hotel. Nestled in the beautiful Bow Valley, the town of Banff's main thoroughfare is cut off at one end by a mountainous rock wall and at the other end by a rock garden. Banff is a year round resort town featuring majestic scenery, a lively Main Street of shops and restaurants and an abundance of outdoor activities including hiking, skiing and golf. Tonight enjoy a Welcome Dinner with your fellow travelers at a local restaurant in Banff.

Meal: (D) Overnight - Banff

#### Day 2: Banff Area Tour

Today enjoy a Banff Area Tour featuring the Banff Springs Hotel, Mt. Rundle, Bow Falls, Tunnel Mountain and the Hoodoos, also referred to as the "Land of Sleeping Giants". Later learn about Alberta's gemstone, Ammonite, one of the world's rarest gems during a Ammonite Factory Visit. This afternoon is at leisure. An optional excursion will be available featuring a Lake Minnewanka Cruise & the Sulphur Mountain Gondola.

Meal: (B) Overnight - Banff

#### Day 3: Banff - Yoho National Park

Today's Canadian Rockies tour features a panorama of snow-capped mountain peaks, glaciers, waterfalls and canyons, and you should also be on the lookout for moose, deer, big-horn sheep and bear. Visit two of the crown jewels of the Canadian Rockies: Moraine Lake and Lake Louise. First stop to view spectacular Moraine Lake and the Valley of the Ten Peaks. Later explore the grounds of the historic Chateau Lake Louise, located within a UNESCO World Heritage site. Capture spectacular views and photos of Lake Louise and Victoria Glacier. Then journey through Kicking Horse Pass into Yoho National Park to see the Natural Bridge, the Spiral Tunnels and stunning Emerald Lake, named for

its deep green color surrounded by towering peaks. Late afternoon return to Banff.

## **Day 4: Calgary City Tour**

This morning travel to enjoy a Calgary City Tour featuring a visit to the Calgary Tower for a panorama of the city and Rocky Mountains. Then drive through downtown streets of Calgary and stop at Scotsman Hill for great views and photos of downtown, the Stampede Park and the Saddledome. Also see the Canada Olympic Park, one of the main sites of the 1988 Winter Olympic Games including ski jumping & the bobsled. Later visit Heritage Park Historical Village, Canada's largest living history museum and one of the Calgary's most visited tourist attractions featuring a recreated village of late 19th and early 20th century Alberta. Staff dress in historic costumes and horse-drawn vehicles add to the charm. This afternoon return to Banff for an evening at your own pace.

Meal: (B) Overnight - Banff

#### Day 5: Banff at Leisure - Icefields Optional

Enjoy the day at leisure to explore on your own. A full day optional excursion will be available featuring the Ice Explorer & the Icefields Parkway, situated between Lake Louise and Jasper. Scale Bow Pass with a stop to see turquoise blue Peyto Lake. The optional excursion highlights a stop at the Columbia Icefield to ride the Ice Explorer, a specially designed Snow Coach on the 1000 foot-thick Athabasca Glacier. Tonight enjoy a **Farewell Dinner** with your fellow travelers at a local restaurant in Banff.

#### **CANCELLATION WAIVER & POST DEPARTURE PLAN**
